- Food handler certificate is needed for anyone handling food at the festival.
- The KCBA must approve all menu & price items and cannot be changed without approval.
- Toronto Korean Festival 2023 may place your booth according to festival themes and location standards depending on the booth merchandise, theme, type of business.

## IMPORTANT - PLEASE READ Market Vendor Rules, Regulations and City Bylaws

## 1. Hours of Operation.

a. Setup will be on Thursday August 24 2023 from 5PM – 8PM,. Vendors must stop sales at 10pm on Friday August 25, Saturday August 26 and Sunday August 27, 2023. Tear down start time is Sunday August 27 10:30 PM and Monday August 28 at 9AM-12PM.

## 2. Number of Booths per Vendor.

a. No vendor will have more than two booths.

#### 3. Electricity.

a. Smaller equipment and basic lighting will be powered with no extra charge. You are responsible for bringing your own extension cords and power bars.

#### 4. Neatness.

a. Vendors will keep their items within a reasonable distance from their booth(s). Vendors display items shall not obstruct foot traffic.

#### 5. Damages.

a. Vendors shall be responsible for any damages they cause to Mel Lastman Square or Toronto Korean Festival property, including any rented equipment from the Toronto Korean Festival.

# 6. Garbage.

a. Garbage is to be disposed of in the 40 yard bin located on site. Please ensure garbage bags are closed securely.

### 7. Noise and pollution.

a. Vendors are not to use equipment that makes excessive noise or air pollution.

#### 8. Security.

a. There will be security patrols provided overnight. However, vendors are responsible for the security of their own equipment and booths at all times, including overnight.

#### 9. Balloons.

a. Helium balloons are not permitted to be sold, distributed or displayed on Mel Lastman Square grounds.

#### 10. Alcohol.

a. No alcohol is permitted to be sold on Mel Lastman Square grounds.

#### 11. Bottled Water.

a. No bottled water is permitted to be sold on Mel Lastman Square grounds

#### 12. Festival Staff.

a. Festival staff will be available to answer questions and assist you during the festival. They will also be ensuring that the festival rules are being followed by everyone. Any vendor found to be non-compliant with one or more of the above rules, their booth will be shut down by festival and Mel Lastman square staff. No refunds or compensation will be granted. If necessary a City of Toronto by-law officer will be called.

# 13. There will be a \$1,000 Fine for dumping Food and Cooking Oil waste on the ground of Mel Lastman Square.
